- 1. Authors note: © Author(s): Last name, name and patronymic name (full); academic degree and rank; position and place of work of all authors. E-mail and telephone. Photo of the author.
- 2. Annotation a short summary of the main points of the entire contents of the article, the basic idea, results. 400 words.
- 3. Keywords. Up to 100 words.

The article is given by the author, on Russian language. The volume is 2.0 quires, for graduates 0,5 quires. Text of the article A4 is writtern in a text editor Microsoft Word: font Bookman Old Style, size 10, line spacing 1,5. Page margins – 2 sm from each edge. Graphic materials, pictures, tables, notes, which are included in the text of the article.

At the end of the article should be writtern a bibliographical list; (References, Notes). Quotations of the authors, which were taken from the books, articles, disserations, and other scientific publications are given in the texts in the square bracets, indicating the number of the pages and years. For example: [1, p. 6]; [2, 2011] and others. The literature, which is quotated by these authors, is writtern only once at the end of the article and it has its number. In the repeated quotations to the same publication indicated the same number. Such procedure is needed to determine the scientific index of using quotations, which are used in the author's texts.

There may also be used in adtion to the bibliographical list of the article different notes and references to laws, archives, statistics, media, Internet, informations, clarifications, comments and other matrerilas. Quotations of the sentences should be made at the end of the page. Numbering of all references in the text should be in order (for example. 1, 2, 3, 4, 5... 25).
